Sub: R/J Examination / Refresher Clinic/Classification Exam.

Dear Sir,

We are pleased to inform you that IBF would be conducting National level R/J Exams / Refresher Clinics and National Classification Exams for National R/Js in the near future, preferably during the Zonal Championships or at a time when a particular Zone could arrange to host the 1 Star Exam.

Please note that all Candidates wishing to appear for any of these Exams have to fulfill the following conditions:

1. The Candidate should be an active R/J at the State/ Board level
2. The Candidate should have officiated as a Referee/Judge in at least 4 State/Board Boxing Championship in the current year and this should have been recorded in the State/National Record Book.
3. The Candidate should have done his yearly medical examination and proclaimed fit.
4. The Candidate should be recommended by the State/ Board Secretary
5. The Candidate will make his own arrangements for Boarding and Lodging during the period of Examination.

We are conducting these Exams so that we could categorize Referees and Judges and use these Officials at various different Boxing Championships and in this way we could get very fair and good results.

Please note that the above criteria's would apply for all exams however the Rating that would be followed would be similar as that of AIBA and as follows:

**Eligibility:**

1. 1 Star National R/J – A State level Referee /Judge who has been regularly officiating in his State/Board with a high level of competence.  
Once he achieves this status, he is eligible to officiate at State/ Board and Zonal level boxing Championships. (Exam will be held at Zonal Championships or at a particular place arranged by Zonal/Board Boxing Association)
  
2. 2 Star National R/J - A 1 Star National R/J who has officiated at a minimum of 6 State/Board or Zonal Boxing Championships.  
As a 2 Star National R/J, he is eligible to officiate at All India Boxing tournaments, Sub Junior and Junior National Boxing Championships. (Exam will be arranged separately by IABF)
  
3. 3 Star National R/J – A 2 Star National R/J who has officiated at a minimum of 10 All India Boxing tournaments, Sub Junior and Junior National Boxing Championships and has been found to be competent.

As a 3 Star National R/J, he is eligible to officiate at Youth, Senior, Inter Zonal and National Games Boxing Championships. (Exam will be arranged separately by IABF)

A 3 Star TO will also be given sufficient exposure at domestic International Boxing Championships and will be given an opportunity to attend Clinics etc so that he gains sufficient knowledge and experience to appear for International R/J 1 Star Exams.

In view of the above, we will appreciate your kind cooperation and request you to kindly register the eligible candidates from your States/Units for 1 Star, 2 Star and 3 Star R/J Exams, as well as for the Refresher Clinic for those who have not appeared for the Refresher Clinic since the last 2 years.

Note: As per AIBA guidelines, Coaches are no more eligible to officiate as R/Js and they should refrain from appearing for R/J exams.

- \* 1 Star National R/J – A State level Referee /Judge who has been regularly officiating in his State/Board with a high level of competence.
- \* 2 Star National R/J - A 1 Star National R/J who has officiated at a minimum of 6 State/Board or Zonal Boxing Championships.
- \* 3 Star National R/J – A 2 Star National R/J who has officiated at a minimum of 10 All India Boxing tournaments, Federation Cup and Inter Zonal National, Sub Junior and Junior National Boxing Championships and has has been found to be competent.
- \* 1 Star National R/J eligible to officiate at State/ Board and Zonal level Boxing Championships.
- \* 2 Star National R/J eligible to officiate at All India Boxing Tournaments, Federation Cup and Inter Zonal National, Sub Junior and Junior National Boxing Championships.
- \* 3 Star National R/J he is eligible to officiate at All National, Federation Cup and Inter Zonal National Boxing Championships, National Games, International Boxing Championships in India and will be given an opportunity to attend Clinics etc so that he gains sufficient knowledge and experience to appear for International R/J 1 Star Exams.
- \* As per AIBA guidelines, all elected members who are Executives of State Association / Federation such as Presidents, EC members, General Secretary etc. as well as Active Boxing Coach / Team Manager are no more eligible to officiate as R/Js and they should refrain from appearing for R/J exams.
- \* The organizer will provide only Boarding facilities to all the candidates one day before and one day after the exam.
