Medical & Weigh-in : General weigh-in and medical examination of

all boxers will be held at the venue from 0800

hrs. on September 15, 2011 and on subsequent days

for those boxers who are drawn to Box.

Draw : Draw will be held immediately on completion of

the medical & weigh-in on September 15, 2011.

Team officials : Only one Coach, one Manager (Female) and one R/J will

be allowed per team.

Boarding/Lodging: Free lodging will be provided to all boxers and officials at

Mehandergarh from September 14-19, 2011.

Arrival particulars : The organisers will have their reception booth

at Mehandergarh Railway Station/Bus Stand.

<u>Important</u>

1. The team/officials shall not arrive at venue earlier than the September 14 and shall leave by September 19, 2011.

- 2. Cost of travel of all participants and team officials upto Mehandergarh will be borne by the respective units.
- 3. In case of extra member in a team, a charge of Rs. 500/- per day will be levied per head per day.
- 4. All boxers must possess their own Gum shield.
- Boxers who are already registered with HSBA/ IBF shall carry their Indent Card otherwise they should carry their original Municipality birth certificate and Age Estimate Format issued by CMO for HSBA/ IBF registration purpose.
- 6. No teams will be allowed to participate unless Affiliation/Entry fees are paid to HSBA.
- 7. Borrowing of boxers from any other unit is strictly prohibited.
- 8. Boxers who do not compete for any reason whatsoever will not be permitted free boarding and lodging and will have to pay Rs. 200/- per head per day in advance to avail of these facilities.
- 9. The championship will be conducted as per IABF rules.

10. Persons accompanying the team as Manager and Coach will not be permitted to officiate in the championship.
