Manager only.

Important

1. The team/officials shall not arrive at venue earlier than the August 19 and shall leave by August 24, 2015.

- 2. Cost of travel of all participants and team officials up to Bhiwani will be borne by the respective units.
- 3 No teams will be allowed to participate unless Affiliation/Entry fees are paid to HSBA.
- 4. The championship will be conducted as per BF rules.
- 5. Every team must have to deposit Rs. 2,000/- as security deposit for accommodation and the same will be refunded after the event is over.
- 6. Boxers who are already registered with HSBA/ BF shall carry their Record Book otherwise they should carry their original Municipality birth certificate along with mark sheet of Class 5th or 8th or 10th or Age verified by the School on their latter head in original for HSBA/BF registration purpose.
- 7. The HSBA Referee / Judge exam will be conducted during the championship.
