Weight Class	:	A team may consist of a maximum number of 10 boxers. Only one entry per weight category from Lt. Fly to super heavy will be permitted. No reserves are allowed.
Eligibility	:	Boxers over 17 years up to 18 years are eligible. (Boxer who were born between 1998-1999)
Medical & Weigh-in	:	General weigh-in and medical examination of all boxers will be held at the venue from 0800-10.00 hrs. on January 23, 2016 and on subsequent days for those boxers who are drawn to Box.
Draw	:	Draw will be held immediately on completion of the medical & weigh-in on January 23, 2016.

- Team officials** : Only one Coach, one Manager (Female) and one R/J will be allowed per team.
- Boarding/Lodging** : Free lodging will be provided to all boxers and officials from January 22-26, 2016.
- Arrival particulars** : The organisers will have their reception booth at Bhiwani Railway Station/Bus Stand.

Important

1. The team/officials shall not arrive at venue earlier than the January 22 and shall leave by January 26, 2016.
2. Cost of travel of all participants and team officials upto Bhiwani will be borne by the respective units.
1. In case of extra member in a team, a charge of Rs. 500/- per day will be levied per head per day.
2. All boxers must possess their own Gum shield.
3. No teams will be allowed to participate unless Affiliation/Entry fees are paid to HSBA.
4. The championship will be conducted as per Boxing India rules.
5. Every team must have to deposit Rs. 2,000/- as security deposit for accommodation and the same will be refunded after the event is over.
