No entry will be accepted after 10th November, 2017 under any circumstances.


- Entry Fee** : Rs. 1000/- (payable to HSBA)
- Weight Class** : A team may consist of a maximum number of 10 Boxers.
No reserve are allowed
- Boxer Eligibility** : Boxers between the age of 19 and 40 according to their year of birth (born between January 1st, 1977 and December 31st, 1998) are eligible to participate in the competition.
- Weight Categories** : 45 kg - 48 kg, 51 kg, 54 kg, 57 kg, 60 kg, 64 kg, 69 kg, 75 kg, 81 kg, 81+ kg.
- Competition Format** : Three (3) rounds of 3 minutes, (one) 1 minute rest between rounds.

- Medical & Weigh-in** : General weigh-in and medical examination of all boxers will be held at the venue from 3 to 5 PM on 15th November, 2017 and on subsequent days for those boxers who are drawn to Box from 0800 hrs. to 0900 hrs.
- Draw** : Draw will be held immediately on completion of the medical & weigh-in on 15th November, 2017.
- Team officials** : 1-5 Boxer(s) – 1 Coach-cum-Manager
6-10 Boxer(s) – 1 Coach & 1 Manager
- One R/J will be allowed per team.
- Boarding/Lodging** : Free Boarding/Lodging will be provided to all boxers and team officials by the organizers from 15th to 19th November, 2017.

Important

1. The team/officials shall not arrive at venue earlier than the 15th November and shall leave by 19th November, 2017
2. Cost of travel of all participants and team officials up to Village Sunariya will be borne by the respective units.
3. No teams will be allowed to participate unless Affiliation/Entry fees are paid to HSBA.
4. The championship will be conducted as per IABF rules.
5. Bowring Boxer Not Allowed (Boxer Carry their Domicile/ Ration Card/Aadhar Card)
6. All boxers must possess their own Gum shield, Red & Blue Vest & Shorts according to their respective corner allocation.
7. No type of body piercing and body accessories is allowed to be worn during the bout.
8. Borrowing of boxers from any other unit is strictly prohibited person(s) accompanying the team as Coach and Manager will not be permitted to officiate in the championship.
9. All Boxers must have their Original Municipality birth Certificate, Aadhar Card and School Certificate in which Father's Name, Mother's Name, Admission No., Admission years, Class and Date of birth.
