- Entry Fee** : For Units Rs. 1000/- (payable to HSBA only)
- Weight Class** : A team may consist of a maximum number of 10 boxers.
Only one entry per weight category from Lt. Fly to super heavy
will be permitted. No reserves are allowed.
- Eligibility** : Boxers over 17 years up to 18 years are eligible.
(Boxer who were born between 1999-2000)
- Medical & Weigh-in** : General weigh-in and medical examination of
all boxers will be held at the venue from 1600-1800 hrs.
on January 6, 2017 and on subsequent days
for those boxers who are drawn to Box.
- Draw** : Draw will be held immediately on completion of
the medical & weigh-in on January 6, 2017.

- Team officials** : Only one Coach, one Manager (Female) and one R/J will be allowed per team.
- Boarding/Lodging** : Free lodging will be provided to all boxers and officials from January 5-8, 2017.
- Arrival particulars** : The organisers will have their reception booth at Railway Station/Bus Stand Tohana.

2. The team/officials shall not arrive at venue earlier than the January 5 and shall leave by January 8, 2017.
3. Cost of travel of all participants and team officials upto Tohana will be borne by the respective units.
8. In case of extra member in a team, a charge of Rs. 500/- per day will be levied per head per day.
9. All boxers must possess their own Gum shield.
10. No teams will be allowed to participate unless Affiliation/Entry fees are paid to HSBA.
11. The championship will be conducted as per Boxing Federation of India rules.
12. Every team must have to deposit Rs. 2,000/- as security deposit for accommodation and the same will be refunded after the event is over.
